4) First Aid Measures:

Container Disposal: Refer to the product label for instructions. Triple rinse empty containers before disposal in the following manner: Invert the container over the spray or mixing tank and allow to drain for at least 30 seconds after the flow has slowed to a drip. Thereafter, rinse the container three times with a volume of water equal to a third of that of the container volume. Add rinsing to the contents of the spray tank before destroying the container in the prescribed manner. Empty containers should not be burnt; puncture and flatten containers and dispose at a licensed landfill site according to local regulations.
